If my membership is terminated for financial delinquency or if I resign my membership and subsequently desire reinstatement of my membership, the requirements of Article III Membership, Section F (4) of the club by-laws shall apply.

**Article III Section F (4) Reinstatement of Membership**

- a. Application, within one year of resignation in good standing, for reinstatement of membership shall require payment of the monthly dues for the period between resignation and application, or payment of the current initiation fee plus a minimum of one month's dues. (understood to be whichever is greater).
- b. Application, after one year of resignation in good standing, for reinstatement of membership shall require payment of the current initiation fee plus one month's dues.
- c. After termination for financial delinquency of a membership of less than one year, application for reinstatement shall require payment of the amount delinquent at the time of termination and the amount of monthly dues between termination and completion of one year's membership plus the current initiation fee and one month's dues. After termination for financial delinquency of a membership of more than one year, application for reinstatement shall require payment of the amount delinquent at the time of termination and the current initiation fee plus one month's dues.

(Members replying for membership following an approved leave of absence in accordance with Section E are exempt from these requirements)
